The willing bidders may present on the schedule day of Tender opening with prior intimation to this office. **Specification of Work:** The engaged worker have to do the following works-

1. Mixing of feed ingredients in vertically integrated modern feed mixing plant taking the ingredients as per stipulated proportion from go-down.
2. Bagging of the finished product.
3. Transportation of feed bags in to different go-downs of Bull Mother Farm and FSBS.




5. Deploying worker should have following characteristics.
  - a. Above 18 years of Age male worker will be deployed.
  - b. Having sound health and capable of performing hard work.
6. Payment will be made in due course on production of bills in triplicate and challan to this end with work done satisfactory certificate from the concern officer.
7. Termination of Contract:- The contract may be terminated at any point of time if the services rendered by the engaged workers found unsatisfactory or detrimental to this Sanstha along with forfeiture of Security Money in full.
8. Security Money will be retained by the Sanstha throughout entire tenure of Contract & will be refunded after satisfactory completion of Contract Period.
