## General Terms & Conditions for submission of EOI.

- 1. Applications for Empanelment of Agency for Procurement of Live Animal from Outside West Bengal having high genetic merit for implementation of different Scheme under Government of West Bengal at decentralized units across the State of West Bengal for 2025-26 may be submitted by an agency having experience in same or similar nature of business of Live Animal Rearing / Supply by exercising one of the following options -
  - (i) As an Individual (Proprietorship) with independent bonafide having sufficient knowledge and established experience in the field of Live Animal Supply/ Rearing.
  - (ii) As an Private Limited Company/Partnership Firm/ Limited Liability Partnership (LLP)/
     Govt. Firm with business in the field of Live Animal Supply/ Rearing /or services therof.

An agency/individual / firm/company etc. shall submit only one proposal. If an agency/ individual/ firm / company submits or participates in more than one proposal, all such proposals shall be disqualified.

- **2.** The Agency should meet minimum pre-qualification criteria for getting empaneled. Only those Agency / Individuals / firms / company which are a small business or a designated Micro or Small Enterprise (SME), who fulfill the following prequalification criteria, need apply in the prescribed EOI forms for getting empaneled:
  - Any Individual (Proprietorship) applying should have work experience of at least 3 (Three) Years, in the field of *similar business in the field of Livestock* in Government / Semi-Government / Private Sector organizations AND an experience as a Proprietor of his/her firm operating a similar business in the field of Livestock Supply /Marketing for at least 3 (Three) Years. The Proprietorship business should have an average annual Financial Turnover (Gross) on similar business as defined, of a minimum of over Rupees 1 (One) Crores during each of the last three consecutive financial years. . Balance sheets of the Proprietorship should be duly audited by Statutory Auditors / Tax Auditors and may be produced on demand.
  - Any Agency in the form of an Private Limited Company/Partnership Firm/ Limited Liability Partnership (LLP) should be operating a <u>similar business in the field of Livestock</u> for at least 3 (Three) years and have an average annual Financial Turnover (Gross) of a minimum of over Rupees 1 (One) Crores during each of the last three consecutive years. Balance sheets of the Agency/ company/firm should be duly audited by Statutory Auditors / Tax Auditors and may be produced on demand.
  - Any Individual (Proprietorship) or Agency as above applying for empanelment must have adequate handling experience of Livestock Rearing /or Marketing which is to be demonstrated by the Individual (Proprietorship) or any Agency as above, by owning or having a formal written tie-up with a registered factory establishment dealing with similar Business

with approved Guidelines of GoI. The said factory establishment should be duly approved by Govt. Rules and Regulations and should preferably have reputed supply Chain to Any States of India as well as Abroad.

• Any Individual (Proprietorship) or Agency as above applying for empanelment must have adequate Transport facilities in West Bengal through owned / leased / rented Livestock Permit Vehicle to facilitate the adequate Supply in time that are under the Criteria (as mentioned herewith) of the Govt. Of West Bengal , A.R.D. Deptt.

- Any Individual (Proprietorship) or Agency as above applying for empanelment must have adequate transportation and distribution infrastructure through owned / leased vehicles for Carrying Animal from Outside West Bengal . In case of leased vehicles, formal lease agreements allowing the Individual (Proprietorship) or Agency as above, the exclusive use of such vehicles at all times may be produced on demand.

- 5. Conflict of Interest: Agency shall not have a conflict of interest. All Agency found to have a conflict of interest, as mentioned below, will be disqualified. The Sanstha's decision will be final.
  (a) A new residue to a new result of interest and information and a second below.
  - (a) Agency in two or more different applications having controlling shareholders in common.
  - (b) The Agency (including their personnel and sub-consultants) that have a business or family relationship (as defined under Companies Act, 2013) with such members of the Corporation Staff who are directly or indirectly involved in this EOI shall not be considered for selection.

**6. Corrupt or Fraudulent practices:** The Sanstha requires that Agency for selection observe the highest standards of ethics during the currency of the panel. In pursuance of this policy for the purpose of these provisions, the terms as set forth below:

- **"Corrupt practice"** means the offering, giving, receiving or soliciting of anything of value to influence decision in matters relating to this EOI;
- "fraudulent practice" means a misrepresentation of facts in order to influence the selection and award of a contract to the detriment of the Corporation, and includes collusive practices among Agency (prior to or after bid submission),

designed to establish bid prices at artificially non-competitive levels and to deprive the Corporation of the benefits of free and open competition.

- "Collusive practice" means a scheme or arrangement between two or more Agency, designed to establish bid prices at artificially, non-competitive levels.
- "Coercive practice1" means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in this tender.

The Sanstha will reject a proposal for award of work if it is determined that the Agency recommended for award of work was engaged in corrupt or fraudulent practices in competing for the work in question. The Corporation's decision will be final and binding.

The Sanstha will declare an Agency ineligible, either indefinitely or for a stated period of time from being awarded a contract / contracts, if at any time it is determined that **there is a conflict of interest** or the Agency was engaged in corrupt or fraudulent practices in competing for the award of work/contract or in executing the contract. The Sanstha's decision will be final.

7. **Integrity Pact**: The Agency shall sign a Pre-Contract Integrity Pact **(Agreement Annexure-D)** and shall note that the pre-contract integrity pact submitted by them along with the application **will** be valid for the tenure of the contract and extension of the contract, if any, thereafter.

## 8. Non-Disclosure clause:

- a) The Agency shall treat all documents, information, data and communication of and with the Sanstha / GoWB as confidential.
- **b)** The successful Agency shall not, without the Sanstha's prior written consent, disclose the contract or any specification, plan, sample or information or data furnished by or on behalf of the Sanstha to any person other than the person(s) employed by the Agency in the performance of the work.
- c) Further, any such disclosure to any such person employed by the Agency shall be made in utmost confidence and should extend only so far as may be necessary and relevant for the purpose of such performance and shall be subject to the terms and conditions of the Non-Disclosure clause.

## 9. Amendment to EOI document:

- 1. - 2. The applications (EOI) along with other documents will be opened & evaluated by the selection Committee of this Sanstha on <u>16.05.2025 : 10.30 AM</u> or onwards.
- 3. The period of agreement will be initially for One Year based on final selection (Stage -II) which may be extended for further successive periods depending upon the satisfactory performance of the Agent.

# **ANNEXURE-III**

#### 1. INTRODUCTION:

Most of the poor people in rural areas of the State are dependent on mixed crop-livestock farming system for their livelihood. Animal Resources Development Department thus plays a major role in supplementing family income and generating gainful employment in the villages, particularly among the landless laborers, small and marginal farmers and especially women. On the other hand, demands for milk, meat, egg & other livestock related products are growing exponentially due to population explosion, high GDP growth, growing urbanization and change in the food habits of the middle & upper strata of the society. 8.GENERAL :
