DETAIL NOTICE FOR ENLISTMENT OF CONTRACTORS

Applications are invited from construction firms having proven track record for enlistment as contractor under P.B.G.S.B.S for the following category of works:

a) Civil Works

b) Electrical Works.

The application forms shall be available from this office on and from 15.07.2013 on all working days between 11am and 3pm on payment of the cost of application form by Cash.

The cost of application form is Rs. 2000/-(Rupees Two Thousand) only and is not refundable under any circumstances.

Separate applications have to be made for enlistment in different category of work.

The last date for submission of application along with all enclosures is 30.07.2013.

Eligibility for enlistment:

a) The applicant must have a registered place of business in West Bengal.

b) The applicant must have requisite experience in execution of jobs under the particular category in which the enlistment is sought.

c) The applicant should not have any record for breach of contract in respect of execution of any work within last three years from the date of application.

d) The applicant must possess valid Trade License, PAN No., Up to date Professional tax & VAT clearance certificates.

e) The applicant seeking enlistment for a particular class, must have valid credential in execution of work under the said category having executed value, in a single tender, not less than 50% of the higher range of work value fixed for enlistment in the said class.

I. For Civil works:

Must have executed at least three works of this category during last three years for a cumulative value of Rs.10 lac out of which one work should have a value of 5.0 Lac.

II. Electrical works:

Must have executed at least three works of this category during last three years for a cumulative value of Rs.5.0 lac out of which one work should have a value of 2.5 Lac.

Xerox copies of all documents, as sought for in the application form and as required to be submitted to establish the eligibility of the applicant, must be attested by the applicant super scribing as 'Submitted by me'.

The original copies of the documents should be produced as and when asked for verification of the authenticity of documents, submitted by the applicant.

Validity of Enlistment:

The initial enlistment shall normally remain valid for a period of 2(Two) years. However the authority reserves the right to extend the validity period, if felt necessary, in the interest of work.

The enlistment shall be made in the following category:

Category	Entitlement value of work.
a) Civil works	Upto Rs. 15 Lac
b) Electrical works	Upto Rs. 5 Lac

The applicant shall have to deposit an amount of *Rs.5000/- (Rupees five thousand)* only for Civil work, as enlistment processing fee, failing which the application shall not be considered for enlistment.

The applicant shall have to deposit an amount of *Rs.3000/- (Rupees three thousand)* only for Electrical work, as enlistment processing fee, failing which the application shall not be considered for enlistment.

The Enlistment processing fee is non refundable and shall have to be deposited along with the application form.

The Enlistment processing fee has to be deposited in the form of Demand Draft/ Pay order to be drawn in favour of 'PASCHIMBANGA GO-SAMPAD BIKASH SANSTHA', payable in Kolkata.
